



## Affidavit for Street Legal Utility Vehicle

I hereby attest to the following facts and information:

I understand that any false statement submitted in this affidavit subjects me to prosecution pursuant to Title 47 Section 4-108 of the Oklahoma Statutes.

As required by Title 47 Section 1-171.1(A) of the Oklahoma Statutes, I affirm that this vehicle has:

1. A bench seat or side-by-side seat for the use of each rider,
2. Four wheels in contact with the ground, but excluding a tractor,
3. A combustion engine with a piston or rotor displacement of 400 cubic centimeters or greater and capable of maintaining speeds of 45 miles per hour or greater,
4. For each occupant, safety belts or safety shoulder harnesses that shall be of a type and installed pursuant to 49 C.F.R., Section 571.208 et seq., and
5. All equipment required by the provisions of Title 47 Sections 12-201 through 12-232 of the Oklahoma Statutes, with respect to equipment on vehicles, including:
  - § 12-203 – 2 head lamps
  - § 12-204 – 2 tail lamps
  - § 12-204.1 – 2 rear license plate lights
  - § 12-205 – 2 red reflectors on the rear
  - § 12-206 – 2 stop lamps
  - § 12-206.1 – turn signals that flash
  - § 12-208 (Only if street legal utility vehicle is over 80" wide) –
    - 2 front amber clearance lamps
    - 2 rear red clearance lamps
    - 2 side marker lamps (Front is amber, rear is red)
    - 2 reflex reflectors (Front is amber, rear is red)
  - § 12-220 – vehicular hazard warning lamps
