Chairman Pratt called the meeting to order at 10:58 a.m.

Secretary Tanyan performed roll call and all officers were present except Vice Chairman Walkup and Councilperson Lincoln.

Chairman Pratt declared a quorum present to conduct official business.

Chairman Pratt gave the invocation.

## Treasurer's Report

### June 2014 Financials presented by Finley & Cook

June 2014 Financial were reviewed and filed.

#### July Security Bank Card Charges

Treasurer Switch moved to approve the July Security Bank Card Charges. Motion passed 2 yeas, 0 nays, 2 absent and 1 abstention.

## Resolution to close Health Programs Account (Stillwater National)

Treasurer Switch moved to approve Resolution I-14-61 a resolution authorizing closure of the account for Health Programs at Stillwater National Bank. Motion passed 2 yeas, 0 nays, 2 absent and 1 abstention.

## Resolution to close Perkins Family Clinic Account (Stillwater National)

Treasurer Switch moved to approve Resolution I-14-62 a resolution authorizing closure of the account for Perkins Family Clinic at Stillwater National Bank. Motion passed 2 yeas, 0 nays, 2 absent and 1 abstention.

### Resolution to close Federal Management Account (First National)

Secretary Tanyan moved to approve Resolution I-14-63 a resolution authorizing closure of the account for Federal Management at First National Bank. Motion passed 2 yeas, 0 nays, 2 absent and 1 abstention.

Treasurer Switch moved to approve **Resolution I-14-66** a resolution authorizing the approval of the Early Headstart Budget (876-405). Motion passed 2 yeas, 0 nays, 2 absent and 1 abstention.

## **Budget Modifications**

Treasurer Switch moved to approve a blanket motion for the Social Services (538), Realty (100-465), Water Management (100-725), Tribal Transportation Program (544), Law Enforcement (543), Aid to Tribal Government (541), Community Fire Protection (542), Indian Child Welfare (540), Education Program (539-561), Tribal Court (537), Vocational Rehabilitation (817), Information Technology IDC (375-300), Public Safety GF (100-700), EPA GAP (837), Agricultural (100-435) and Library GF (100-570) budget modifications. Motion passed 2 yeas, 0 nays, 2 absent and 1 abstention.

The Maintenance IDC (375-410) budget modification was not approved.

### **Enrollments**

Treasurer Switch moved to postpone enrollments. Secretary Tanya is on conference call and cannot review and approve the enrollment files. Motion to postpone passed 2 yeas, 0 nays, 2 absent and 1 abstention.
