Swearing in of Vice Chairman Renee Lincoln

Treasurer's Report

June 2015 Financials

June 2015 financials were presented for review. Total assets for all Governmental funds was \$27.5 million, total liabilities for all governmental funds was \$4.6 million and total of all liabilities and fund balances was \$27.5 million. Total Revenues for all governmental funds was \$4.9 million, total expenditures for all governmental funds was \$9.4 million, gaming transfers in was \$6 million and fund balances at the end of the year was \$22.9 million.

New Budgets

2015 Clinic Budgets

Treasurer Shores moved to approve <u>Resolution I-15-59</u> a resolution authorizing the approval of the 2015 Clinic Budgets. Motion passed 3 yeas, 0 nays, 1 absent and 1 abstention.

Diabetes (626-000)

Treasurer Shores moved to approve <u>Resolution I-15-60</u> a resolution authorizing the approval of the Diabetes (626-000) budget. Motion passed 3 yeas, 0 nays, 1 absent and 1 abstention.

VOCA 2015 (611-000)

Vice Chairman Lincoln moved to postpone the <u>VOCA 2015 (611-000)</u> budget until a grant abstract has been submitted. Motion passed 3 yeas, 0 nays, 1 absent and 1 abstention.
