Councilperson McClellan moved to approve <u>Resolution I-15-46</u> a resolution recognizing and waiving any conflict of interest related to nepotism on behalf of Bobby Walkup which might have arisen as a result of him having assumed office with the Business Committee of the Iowa Tribe of Oklahoma. Motion passed 3 yeas, 0 nays, 0 absent and 1 abstention.

Motion passed 3 yeas, 0 nays, 0 absent and 1 abstention.

Councilperson McClellan moved to approve <u>Resolution I-15-57</u> a resolution authorizing Chairman Bobby Walkup and Treasurer Judith Shores to execute contracts by the majority approval of the Iowa Tribe of Oklahoma Business Committee with corrections.
