General Education Development (GED) High School Equivalency Test (HISET)

1. The application is for enrolled adult tribal members of the Iowa Tribe of Oklahoma.
2. Iowa Tribe of Oklahoma members residing anywhere are eligible to make applications.
3. Applications are always open for submission.
4. Please be sure all requested application checklist documents are submitted with application.

Eligibility Guidelines:

1. Must be an enrolled member of the Iowa Tribe of Oklahoma
2. Completed program applications must be submitted to the ITO Higher Education department to be accepted from the testing institution.
3. Applicants must be adults 18 years or older.
4. Testing fees will be paid directly to the testing agency. Please allow time to process.
5. The GED-HISET Program will pay for (1) full subject test and (2) retake tests of single subjects that are scored below passing. These are lifetime limits of testing fee benefits.
6. All test scores must be turned in to the ITO Higher Education Department after ANY exam.
7. To obtain a single subject(s) retake tests, previous test scores must be submitted with a new application.
8. Completed program applications must be submitted to the ITO Higher Education Department to be accepted.

Application Checklist

Required Documents:

- Iowa Tribe of Oklahoma enrollment card.
- Completed application.
- GED-HISET testing fees are the only allowable expenses to request.
- Proof of testing fee amounts from an accredited testing agency. Examples of proof can be in the form of a flyer or statement on letterhead from a testing agency.
- W9 from an accredited testing agency to establish payment.
- Previous GED-HISET scores if applicant is applying for single subject(s) retake testing benefits.
- Written narrative detailing applicants' educational goals OR use for testing.
- No reimbursements or payment of past exams will be funded. All payments will be for new upcoming exams and paid directly to the testing agency.

All information requested is necessary to determine eligibility.
